# High Water Update

- Judge Tomlinson participated in a conference call this week with the National Weather Service, Army Corp of Engineers and state officials regarding the severe weather and flooding concerns. Residents of low lying areas need to be ready to move. Assistance is available on an individual basis.
- KY Emergency Management has advised counties to proceed with emergency declarations.
- Mound Hill Road is currently only one lane due to the recent slide. The estimate to repair of approximately \$165,000.

#### Watershed Update

The bids have been opened. Hale Construction will be the contractor for the Mellins Branch/Carlisle Road project. The remaining 2 projects were over the estimates and are in negotiations with low bidders. No action taken.

# **ADF Grant Applications**

Applications submitted by the deadline are from Park to Park Trails, Pt Wm Historical Society and American Legion Ladies Aux. The court members need to review, prioritize and make recommendations to the Area Development District. No action taken.

#### <u>Ambulance</u>

The court was to meet with Ed Webb prior to court regarding the proposals for a new ambulance. Not all court members have had a chance to do so. No action taken.

#### County Road Report

A number of county roads have been underwater. The Road Dept. has been monitoring the situation. No action taken.

### State Road Report

The state will be letting bids on KY Hwy 227 and KY Hwy 389 soon. No action taken.

## **County Judge's Comments**

- Due to recent theft problems, a computer at the EOC and a trailer for Solid Waste need to be replaced. The value was estimated at \$2000 and the Sheriff's Office is investigating.
- Judge Tomlinson recommended the purchase of a used coroner's cooler from another county for \$1000. Magistrate Miller made the motion. Magistrate Bowling 2<sup>nd</sup>. All in favor. Motion carries.

• A local resident believes that the county trucks turning around in his driveway in the winter has possibly caused salt damage to the concrete. There is no way to know if the trucks actually caused the pitting of the concrete and the court agreed that it is not the county's responsibility to repair.
