# Carroll County Fiscal court Minutes March 8, 2011

The regular meeting of the Carroll County Fiscal Court was held Tuesday, March 8, 2011. Members present were Judge/Executive Harold "Shorty" Tomlinson, Magistrate Floyd Bowling, Magistrate Dean Miller, Magistrate Mark Bates and County Attorney Nick Marsh.

### Call to Order

Judge Tomlinson called the meeting to order at 9 a.m., observing a moment of silence for those less fortunate, those in the community that are dealing with death and illness and our servicemen and women.

A grant opportunity through the KY Board of Emergency Medical Services is available and can be applied toward the purchase of a new or refurbished ambulance and equipment. The amount is \$11,009.17. No action taken.

# Economic Development Meeting – Henry County

Henry County is working on an industrial park and bringing industry to the community. Judge Tomlinson was on the panel for discussion at their recent meeting and emphasized the need to work together as a region to bring jobs to the area. Magistrate Miller questioned whether we have a list of available properties for development in the county. Judge Tomlinson responded that there is a list. No action taken.

# Engineering Firm/Bridge Projects

A bridge report from DOT indicates a problem with the bridge on Painter Road. It needs to be bid out for repair or replacement. Magistrate Bates made a motion to approve ETRAN as the engineering firm for the project. Magistrate Bowling 2<sup>nd</sup>. All in favor. Motion carries.

#### Traffic Signal

#### Speedway Meeting

#### Resurfacing – County Roads

Our current contract with OVA is renewable for 12 months. Magistrate Bates made a motion to extend the contract. Magistrate Bowling  $2^{nd}$ . All in favor. Motion carries.

State Roads

- The state will let bids in April.
- Judge Tomlinson has requested discretionary funds from the state in the amount of \$215,000 for resurfacing of 3.7 miles of Hwy 389, from English to the Henry County line.
- A request has also been made for funding for bridge replacement on Painter Road. There is additional funding available this year.
- Magistrate Bowling inquired about the patched bridge on Locust. The state has indicated that they will fix.

No action taken.

### Road Supervisor

Supervisor Doug Crawford asked about a new mower for the road department. Magistrate Miller thought that there were to be bids. The court will discuss and take action at the next meeting.

#### Judge's Comments

- A report was received from Community Action. Funding cuts are inevitable.
- JCTC Open House went well.
- A Thank You was received from the Prescription Assistance Program.
- Carroll County Health & Safety Fair has been scheduled for March 26.
- A Senior Citizens letter received regarding funding concerns.
- Lisa Cooper has been appointed as Assistant Director with the Area Development District.
- Requested court members help with fund raising for the Boy Scouts.
- Submitted a quote from Junior Welch for re-seeding the courthouse lawn. Magistrate Bates inquired about the sidewalk grant. The project will begin once the MOA is received. Magistrate Miller questioned whether the Road Department can seed the lawn rather than outsourcing. No action taken.

<u>County Attorney Comments</u> County Attorney Nick Marsh commended the Child Support Workers for their recent collection efforts.
