# Carroll County Fiscal Court Minutes May 10, 2011

The regular meeting of the Carroll County Fiscal Court was held Tuesday, May 10, 2011. Members present were Judge/Executive Harold "Shorty" Tomlinson, Magistrate Floyd Bowling, Magistrate Dean Miller, Magistrate Mark Bates and County Attorney Nick Marsh.

#### Call to Order

Judge Tomlinson called the meeting to order at 9 a.m., observing a moment of silence for our servicemen and women and for those dealing with flood issues in the south.

#### **Approve Minutes**

Magistrate Bates made a motion to approve the minutes of the April 27, 2011 meeting. Magistrate Miller 2<sup>nd</sup>. All in favor. Motion carries.

# **Library Board Appointment**

On Judge Tomlinson's recommendation, Magistrate Miller made a motion to appoint Jama Snyder to the Public Library Board of Trustees for a term to expire June 30, 2015. Magistrate Bates 2<sup>nd</sup>. All in favor. Motion carries.

#### Watershed Projects Update

Judge Tomlinson updated the court that Hale Construction was the successful bidder for the Carlisle Road/Mellins Branch project. The Four Mile and Whites Run project bids were both higher than the engineer's estimates. NRCS declined negotiated prices submitted by low bidders. NRCS engineers will be meeting with the low bid contractors to assess the differences. Informational, no action required.

#### **ADF Grant Prioritization**

Judge Tomlinson recommended splitting the \$5670 as follows:

- Port William Historical Society \$2235
- Park to Park Trails \$2235
- American Legion \$1200 (there is a question whether the funds can be utilized for this request)

Magistrate Bates made a motion to approve Judge Tomlinson's recommendation. Magistrate Bowling  $2^{nd}$ . All in favor. Motion carries.

#### **Grant Update**

Judge Tomlinson updated the following grants:

- Rescue Squad Canine Search & Recovery was awarded \$4730.
- The Homeland Security grant for radios is completed and closed.
- The Homeland Security grant for the MDC project is completed and closed. Information, no action required.

#### **Ambulance**

Judge Tomlinson asked the court to make a decision regarding the bids for an ambulance. The grant deadline is approaching and, if not spent, the funds will have to be sent back. The court reviewed prior discussions and the bids that were received several weeks ago. Ed Webb discussed his concerns with the bid proposals. There is a contradiction with the low bid regarding service capabilities and loaner ambulances and the bid was reviewed by County Attorney Marsh. The bids were presented as follows:

- Southeastern Specialty Vehicles \$92,999.
- LifeStar Rescue \$101,046. (E-450)
- LifeStar Rescue \$112,996. (F-450)
- Braun \$157.607.

Magistrate Miller made a motion to purchase the F-450 from LifeStar Rescue for \$112,996. Magistrate Bowling  $2^{nd}$ . All in favor. Motion carries

Jeff Bert with NKADD is working on the reapportionment on our behalf. Judge Tomlinson recommended compensation of \$250 per individual board member, upon completion of the reapportionment. The board members are Alice Marsh, County Clerk (nonvoting), Margaret Brierly from District 2, Don Ford from District 1 and Grover Crawford from District 3. Magistrate Bates made a motion to approve the compensation for board members. Magistrate Bowling 2<sup>nd</sup>. All in favor. Motion carries.

Judge Tomlinson presented the attached proposed FY 2011-2012 budget to the court. The budget is \$10,846,770 and includes 3% pay increase for county employees and 1.5% pay increase for elected officials.

Magistrate Bates made a motion to approve the attached Pre-approved Recurring Expenses for FY 2011/2012. Magistrate Bowling 2<sup>nd</sup>. All in favor. Motion carries.

- A letter from corrections was received addressing the corrective actions of the jailer to recent write ups during their inspection.
- The KY Economic Development Guide is in and the county's article looks good. Informational, no action required.
