Grants/State Road Report

- A \$75,000 energy grant will be funded to upgrade the heating/ac of the courthouse.
- The resurfacing contingency funds (\$150,000-155,000) will be used on Goose Creek.
- The flex funds will be used for Whites Run Road.
- The in-place patching funds will be used on Mound Hill Road.

Bid openings

Bids were being accepted for work on the Old Gilgal Tunnel and the old Ambulance building concrete slab. States, Inc. did not attend the mandatory prebid meeting for the Old Gilgal Tunnel and the bid will not be opened or considered. The bids were received as follows:
