The hospital recently made a \$100,000 payment on the loan the court had given them. Judge Tomlinson recommended contributing the money back to the hospital, after an agreement is reached on how the money will be spent. No action taken.

Outgoing Sheriff Ben Smith requested the court allow him to keep his firearm. This has been done for sheriffs in the past and the court was in agreement to allow him to keep his firearm.

Detention Center Report

The jailer has responded to items that the facility was written up for in recent inspections and the responses were accepted by the state. No action taken.
