### Carroll County Fiscal Court Minutes January 25, 2011

The regular meeting of the Carroll County Fiscal Court was held on January 25, 2011. Members present were Judge/Executive Harold "Shorty" Tomlinson, Magistrate Floyd Bowling, Magistrate Dean Miller, and Magistrate Mark Bates. Judge Tomlinson called the meeting to order at 9a.m., observing a moment of silence for our men and women overseas and those less fortunate in the community.

#### **Approve Minutes**

Magistrate Bates made a motion to approve the Minutes of the January 11 meeting. Magistrate Bowling  $2^{nd}$ . All in favor. Motion carries.

#### **Budget Transfers**

Magistrate Miller made a motion to approve the attached budget transfers. Magistrate Bates  $2^{nd}$ . All in favor. Motion carries.

#### **Invoice Approval**

Magistrate Miller made a motion to approve the attached invoices. Magistrate Bowling  $2^{nd}$ . All in favor. Motion carries.

#### Watershed Projects

Judge Tomlinson informed the court that three additional watershed projects had been approved. They are: Whites Run, Carlisle Road, and 4 Mile. The documents have been signed and mailed and should be received by the County Judge any time.

#### Jailer—Foodservice

Jailer Mike Humphrey was on hand to discuss with the court the possibility of contracting an outside vendor to handle the food service at the jail versus having jail employees prepare the meals. One of the cooks will be retiring soon and a decision will have to be made to replace the cook, or to contract with another agency.

The Jailer has received bids for a new phone system at the Jail and will be making a decision soon.

The Jail is installing new surveillance cameras on the premises.

#### Kentucky Fatalities Report

There were 753 total fatalities in Kentucky during 2010.

### JCTC Adult Education Report

Judge Tomlinson announced the Adult Education and Family Literacy Program at JCTC is continuing to grow and has rated excellent recently. They are also reporting an increase in enrollment.

#### **Hospital Projects**

Kanute Rarey, Carroll County Memorial Hospital CEO was on hand to present a list of projects needed at the hospital. After some discussion, Magistrate Miller made a motion to send the appropriated \$100,000 to the hospital leaving the hospital with the flexibility to use the money in whatever manner it is needed. Magistrate Bowling  $2^{nd}$ . All in favor. Motion carries.

#### **Ambulance**

The court discussed the ambulance bids opened in December.

DES Director Ed Webb advised the court that there were no state contracts available for the purchase of ambulances.

After review and discussion, Magistrate Miller made a suggestion to re-bid for a new 2010 and 2011 ambulance as well as for a refurbished ambulance. The court was in agreement and also advised Mr. Webb to call around to various dealers to invite them to bid.

#### **County Road Report**

Judge Tomlinson and the court commended the County Road Department on excellent work keeping the roadways clear during the recent snow. So far this season, the county has spent an estimated \$58,000 on salt.

Hinkle Holding Company has contacted the county asking they take over the Hunters Ridge Subdivision. After a recent meeting with the Judge, it was agreed the county would not be responsible for the mowing of the medians, or the retention pond. Also, it was mentioned that Hinkle would have to clear the ditches before the road could be accepted into the county road system. Magistrate Bates made a motion to accept. Magistrate Bowling 2<sup>nd</sup>. Majority in favor. Motion carries.

Magistrate Miller opposed.

County Judge Comments

Judge Tomlinson updated the court on the recent KBT Conference he attended.

Upon recommendation of the County Judge, Magistrate Miller made a motion to reappoint Tim Hibbard and Don Mougey to the Carroll County Tourism Board. Magistrate Bowling 2<sup>nd</sup>. All in favor. Motion carries.

Scott Brown with Phil Brown Insurance Agency updated the Judge that due to 10 employees changing from the Traditional to the HRA Insurance Plan, the overall insurance increase was 7% instead of the 10% originally predicted.

Judge Tomlinson presented an Economic Development Magazine to the court to get opinions on possibly putting an advertisement in the magazine.

#### Adjournment

Magistrate Bowling made a motion to adjourn. Magistrate Miller 2<sup>nd</sup>. All in favor. Motion carries.
